POSITION TITLE: PILOT New Commission Multiple positions (18X) 2LT-MAJ	AREA OF CONSIDERATION: NATIONWIDE All candidates may apply who meet the basic qualification for this position and who are eligible for membership in the NYANG.
<p>Upon ANGRC approval, member enters a one year training program to qualify and perform as an MQ-9 Air National Guard pilot. The following schools are mandatory for successful completion of the RPA Pilot Training Program:</p> <ol style="list-style-type: none"> 1. Screening Physical – Wright Patterson AFB, OH (3 days) 2. Total Force Officer Training (TFOT) - MAXWELL AFB, AL (8 weeks) 3. Initial Flight Training- Pueblo Colorado (8 weeks) 4. 18X Track- RPA Instrument Qualification & Fundamentals Course – Randolph AFB, TX (20 Weeks) 5. MQ-9 Transition Training – Holloman AFB, NM or Hancock ANGB, NY or March ARB, CA (21 Weeks) 	
QUALIFICATIONS AND SELECTION FACTORS	
<ul style="list-style-type: none"> - Selection for this position will be made without regard to race, religion, color, creed, gender or national origin. - Applications are subject to review by the Force Support Squadron upon initial submittal, and as mandatory requirements are met, as outlined in applicable regulations. -The requirements and qualifications prescribed in this announcement are minimum for nomination for appointment consideration. Appointment is not assured merely by meeting these requirements. Persons considered must further qualify with requirements outlined in AFI 36-2005. - A selection of two to four Primary candidates and two Alternate candidates will subsequently be made for four projected quotas for FY 20. Applicants meeting the general pilot requirements will be notified in writing of the date, time and place to appear before the Officer Screening Interview Board (OSIB). Non-qualified applicants will be notified in writing of any disqualifying factors which preclude their consideration by the OSIB. 	
<p>KNOWLEDGE: Knowledge is mandatory of theory of flight, air navigation, meteorology, flying directives, aircraft operating procedures, and mission tactics.</p> <p>EDUCATION: Applicant must possess a Bachelor's degree, or complete a Bachelors degree prior to applying. An undergraduate degree specializing in physical sciences, mathematics, administration or management is desirable.</p> <p>TRAINING: The following training is mandatory as indicated: For entry into 18AXB, completion of Air Force Undergraduate Remotely Piloted Aircraft Training (URT), or possess an aeronautical rating of Pilot or Navigator/Combat Systems Operator (CSO). For award of AFSC 11U3X / 18A3B, completion of transition and operational training in the suffix specific aircraft.</p>	
<p>EXPERIENCE: For upgrade to AFSC 11U3X / 18A3X, unit commander determines proficiency based on performance, experience, and completion of minimum training requirements. See AFMAN 36-2105.</p>

OTHER QUALIFICATIONS:

1. Per AFI 36-2105, undergraduate flying training applicants who are under the age of 33 and/or have less than 8 years of total federal commissioned service (TFCS) may apply without an exception to policy. Individuals beyond their 33d birthday and/or have greater than 8 years TFCS will require an exception to policy under provisions in AFI 36-2105.
2. Applicants must meet physical, citizenship, moral and education requirements to be an officer and pilot in the Air National Guard in accordance with AFI 36-2005. Any/all other RPA appointment criteria in accordance with AFI 36-2105 and other governing regulations must be met.
3. Must satisfactorily complete the AF Officer Qualifying Test (AFOQT) prior to selection board. AFOQT scores must be equal to or greater than the following percentiles: PILOT- 25, VERBAL-15, QUANTITATIVE-10. Applicant is encouraged to contact SMSgt Bradley Addison @ (315) 233-2147 ASAP to schedule the test. The results must be available prior to scheduling the OSIB. (Applicant may apply for position prior to test taking).
4. Pilot Candidate Selection Method (PCSM) score MUST be available to the pre-screening board and be AT LEAST 10. The Test of Basic Aviation Skills (TBAS) is a factor of the PCSM and therefore also needs to be accomplished prior to applying. <http://access.afpc.af.mil/pcsm/mz/index.html>
5. Specialty requires routine access to Top Secret material or similar environment. Each applicant must have a favorably completed personnel security investigation and a Single Scope Background Investigation (SSBI) in accordance with AFI 31-501. Award of entry level without a completed SSBI is authorized provided an interim Top Secret security clearance has been granted according to AFI 31-501.
6. Selection process is as follows:
 - A. A pre-screening board will meet o/a 23 Apr 19 to review all applications received by the announcement closing date.
 - B. Applicants will be notified for interviews. An Officer Screening and Interviewing board (OSIB) is projected to convene 4-5 May 19 to interview qualified applicants.
 - C. Selectees must pass a Commissioning Physical and Class I Flying Physical Exam.
7. Selectees must agree to remain a member of the NYANG for a minimum of six years after graduation of Undergraduate RPA Training (URT). Non-prior service selectees **must enlist** into the NYANG (174th Attack Wing) prior to the application package being forwarded to higher headquarters for approval.

Applicants will prepare and forward a Cover letter, Resume, Completed AF Form 24 - Application of Appointment as Reserves of the Air Force or USAF Without Component, AFOQT score, Current Official College transcripts (forwarded directly from college to address below), vMPF Record Review Rip (if applicable), Current Physical Fitness Evaluation Report (if applicable), Pilot license and flight log (if applicable) and PCSM/TBAS scores, **No Later Than Close of Business of Announcement Closing Date.** Include all other data that might help you qualify as a top candidate. INCOMPLETE PACKAGES WILL NOT BE CONSIDERED
